SIXTH AMENDMENT TO AGREEMENT NO. 33400

THIS SIXTH AMENDMENT TO AGREEMENT NO. 33400 is made and entered, in duplicate, as of May 29, 2019, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on May 7, 2019, by and between BAKER CREW CONSULTING, INC., a Wyoming corporation, located at 109 E. 17th Street, Suite 4431, Cheyenne Wyoming 82001-4543 ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the City requires specialized services requiring unique skills to be performed on an as-needed basis in connection with professional and technical services for information technology projects and systems; and

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 33400 (the "Agreement") whereby Consultant agreed to provide these services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to increase the not to exceed amount to \$600,000; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to increase the not to exceed amount to \$900,000 and extend the term to January 22, 2017; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to increase the not to exceed amount to \$1,000,000 and extend the term to January 22, 2018; and

WHEREAS, the Parties entered into a Fourth Amendment to the Agreement to increase the not to exceed amount to \$1,500,000 and extend the term to January 22, 2019; and

WHEREAS, the Parties entered into a Fifth Amendment to extend the term to May 22, 2019; and

WHEREAS, the Parties desire to extend the term to October 22, 2019; NOW, THEREFORE, in consideration of the mutual terms, covenants, and

conditions herein contained, the Parties agree as follows:

- Section 2 of the Agreement is hereby amended to read as follows: 1.
- "2. TERM. The term of this Agreement shall commence on January 22, 2014, and shall terminate on October 22, 2019, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner."
- Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 33400 are ratified and confirmed and shall remain in full
