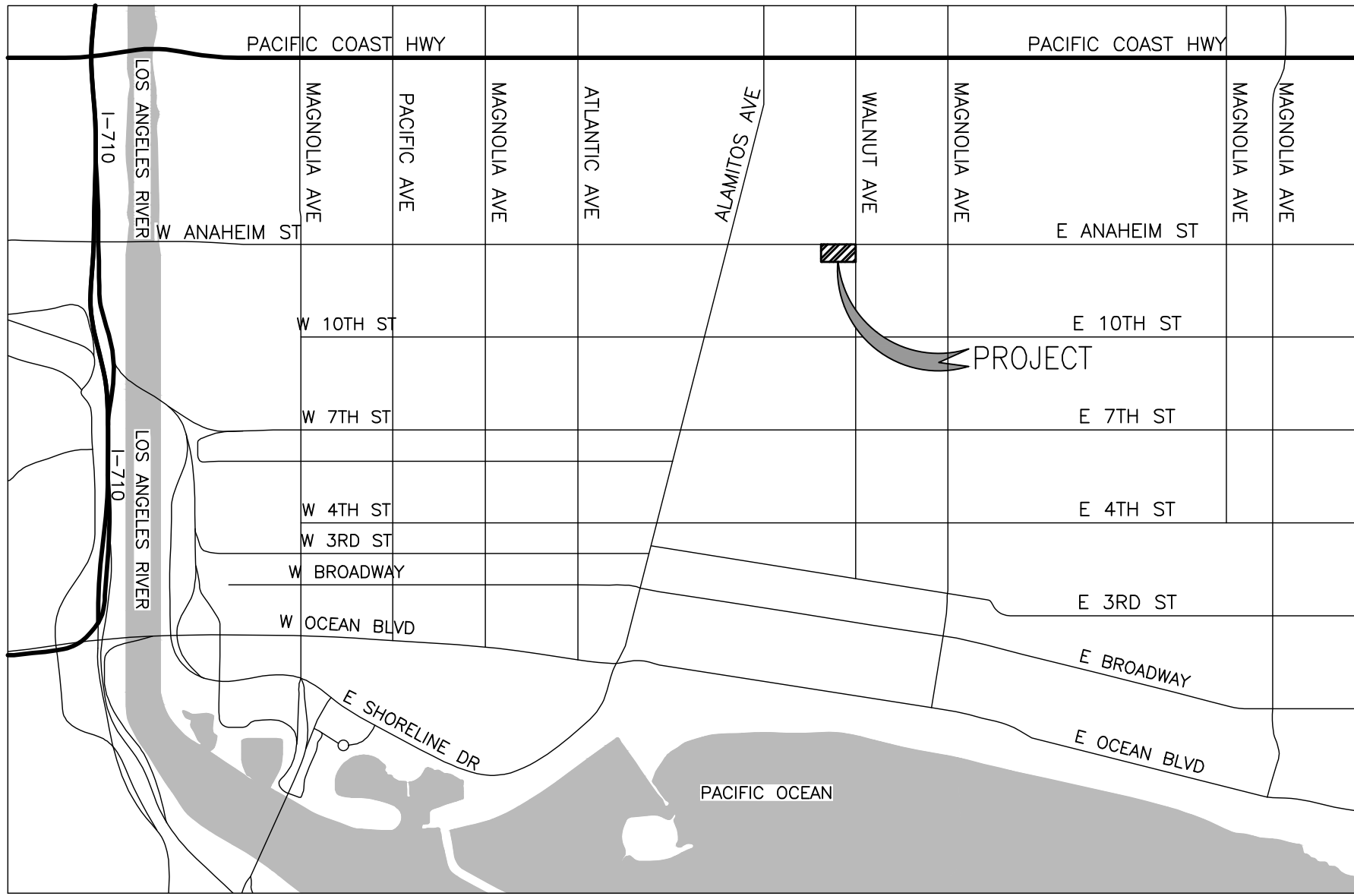

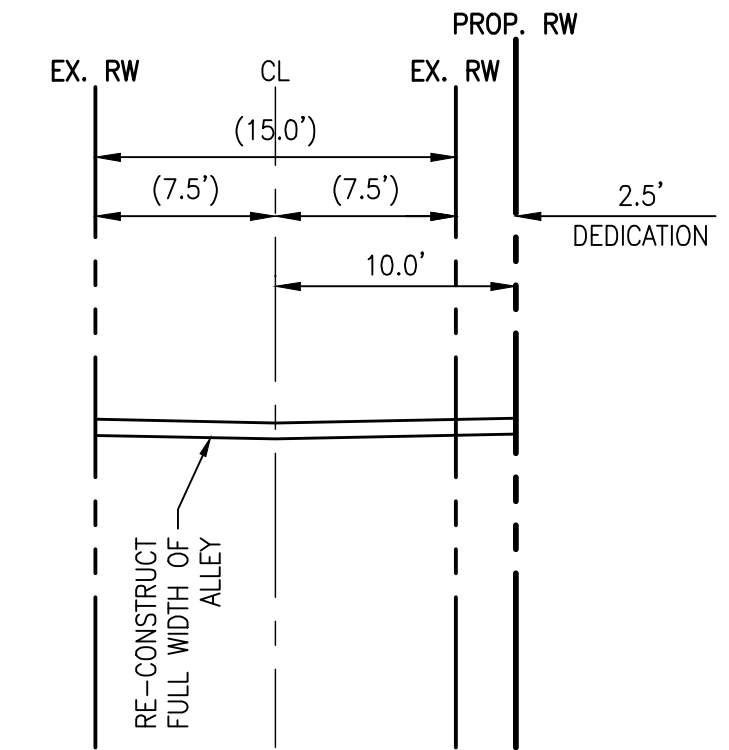


GROUND LEVEL PLAN VIEW



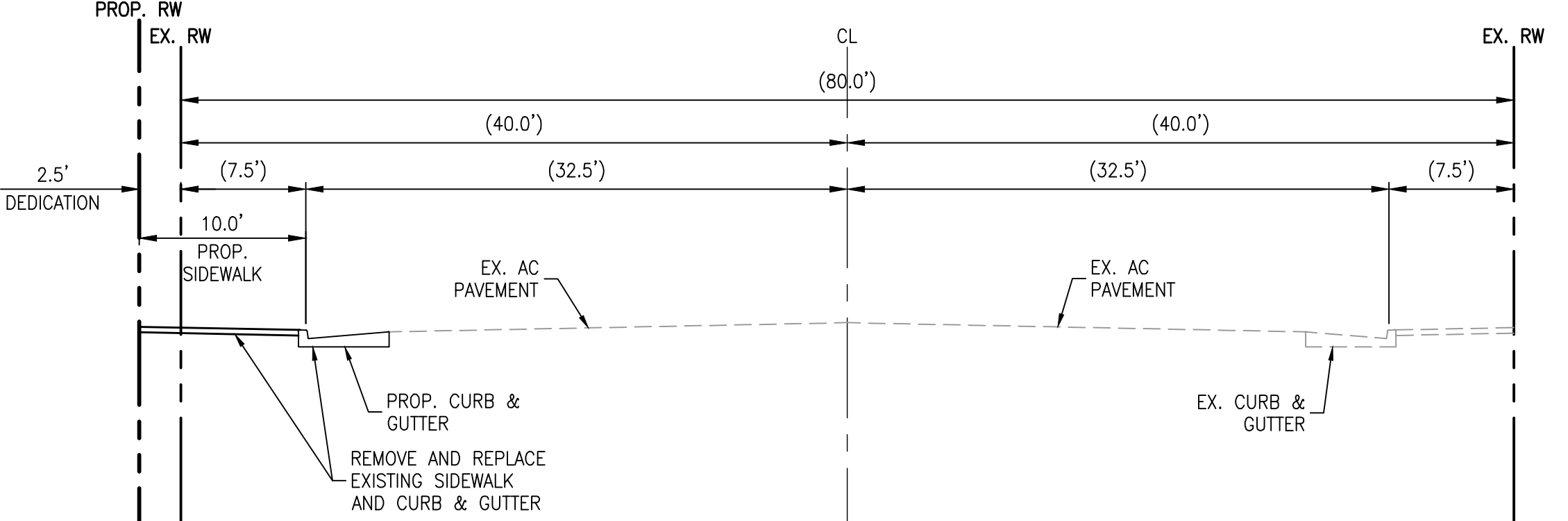
SECTION 'C' - WALNUT AVENUE

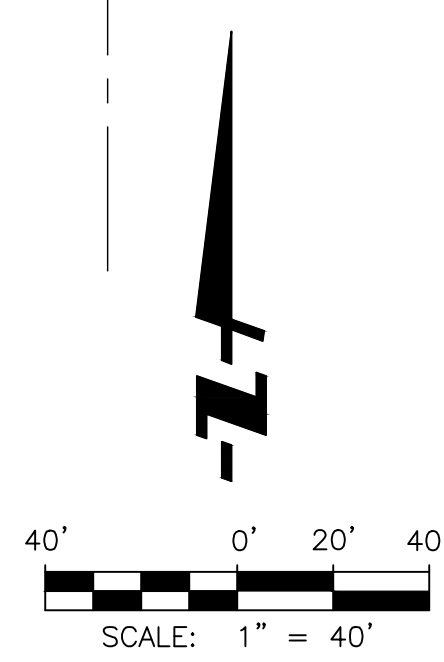
