## **FOURTH AMENDMENT TO AGREEMENT NO. 33912**

THIS FOURTH AMENDMENT TO AGREEMENT NO. 33912 is made and entered, in duplicate, as of June 20, 2019 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on June 2, 2015, by and between KARDENT, a California corporation ("Consultant"), with a place of business at 11 Golden Shore, Suite #540, Long Beach, California 90802, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with as-needed architectural services; and

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 33912 (the "Agreement") whereby Consultant agreed to provide these services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to extend the term to July 19, 2018 and add \$500,000 for a total not to exceed amount of \$900,000; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to add \$300,000 for a total not to exceed amount of \$1,200,000 and extend the term to July 19, 2019; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to update the rates/charges to include two (2) new sub-consultants; and

WHEREAS, the Parties desire to extend the term one (1) additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 2 of the Agreement is hereby amended to read as follows:
- "2. <u>TERM</u>. The term of this Agreement shall commence at midnight on July 20, 2015, and shall terminate at 11:59 p.m. on July 19, 2020, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner."
