WHEREAS, on February 7, 2017, the Long Beach City Council voted unanimously to support Los Angeles County Measure H, the Los Angeles County Plan to Prevent and Combat Homelessness; and

WHEREAS, Measure H passed and established a new quarter cent sales tax in Los Angeles County for ten years in order to fund homeless services and prevention programs; and

WHEREAS, Measure H revenues will be awarded to public agencies to address the aforementioned homeless issues;

NOW, THEREFORE, the Housing Authority of the City of Long Beach, California resolves as follows:

Section 1. The Assistant Executive Director and the Deputy Executive Director are hereby authorized to execute all documents necessary to accept funds from the County of Los Angeles to implement the Homeless Incentive Program.

Section 2. The Clerk will certify to the passage of this resolution by the Housing Authority of the City of Long Beach, California, and it will immediately take effect.
