A RESOLUTION TO TEMPORARILY CLOSE AND REMOVE FROM PUBLIC USE CERTAIN STREETS AND ALLEYS IN THE CITY OF LONG BEACH IN CONNECTION WITH THE CONDUCT OF THE 2006 TOYOTA GRAND PRIX OF LONG BEACH

The City Council of the City of Long Beach resolves as follows:

Section 1. The City Council of the City of Long Beach finds and determines that the conduct of the 2006 Toyota Grand Prix of Long Beach on the streets of the City of Long Beach and the coverage thereof by the media provides a unique opportunity for the City of Long Beach to publicize and call attention to the City, its natural advantage, 15 resources, enterprises, attractions, climate and facilities.

- Sec. 2. For the conduct of the 2006 Toyota Grand Prix of Long Beach, the 17 following streets will hereby have temporary lane reductions for the periods stated:
 - From February 6, 2006 at 9:00 a.m. to May 14, 2006, at 11:59 p.m., Shoreline Drive westbound from Ocean Boulevard to Long Beach Arena service road (reduce existing three lanes of two lanes).
 - b. From February 6, 2006, at 7:00 a.m. to May 14, 2006, at 11:59 p.m., Shoreline Drive eastbound from Linden to Ocean Boulevard (reduce existing three lanes to two lanes).
 - From February 17, 2006 at 7:00 a.m. to May 3, 2006 at 11:59 p.m., Seaside Way, westbound from Pine Avenue to Linden Avenue (reduce existing two lanes to one lane in each direction).
 - d. From February 23, 2006 at 7:00 a.m. to April 26, 2006 at 11:59 p.m., Pine Avenue from Ocean Boulevard southbound to Shoreline Drive

- c. From April 5, 2006, at 7:00 a.m. to April 10, 2006 at 5:00 p.m., Seaside Way from Pine Avenue to eastern end, Linden Avenue from Ocean Boulevard to Seaside Way, Marine Way from Locust Avenue to Collins Way, Atlantic Way from Ocean Boulevard to Seaside Way, Marine Way from Hart Place to eastern end, Linden Avenue, northbound and southbound from Shoreline Drive to Marina Parking lot.
- d. From April 5, 2006, at 9:00 a.m. to April 10, 2006, at 5:00 p.m., Shoreline Drive westbound from Ocean Boulevard and Alamitos to Ocean Boulevard exit ramp northbound, Chestnut Place southbound and northbound from Seaside Way to Queensway Bridge.

The temporary closing of the above streets, alleys, walkways, 13 Promenade and Bike Path for the times herein provided is necessary for the safety and 14 protection of the participants and spectators in the 2006 Toyota Grand Prix of Long Beach 15 and qualifying events to be held from April 7, 2006 through April 9, 2006, utilizing the streets 16 described herein.
- Sec. 5. For the period of 9:00 a.m. to 3:00 p.m. on March 28, 2006, the 18 streets and alleys described in Sections 3.c. and 3.d. above are hereby withdrawn and 19 removed from public use.
- Sec. 6. For the period April 7, 2006, at 6:00 a.m. to April 9, 2006, at 11:59 21 p.m., Shoreline Drive from Ocean Boulevard to Chestnut Place, Chestnut Place from Shoreline Drive to Seaside Way, Pine Avenue from Ocean Boulevard to Shoreline Drive and Seaside Way from Pine Avenue to eastern end are hereby withdrawn and removed 24 from public use.
- Sec. 7. For the period of April 7, 2006 at 6:00 a.m. to April 9, 2006 at 6:00 26 p.m., Seaside Way from Chestnut Place to the eastern limit (dead end beyond Linden), Bay Street from Pine Avenue to the Pike Garage Structure, Aquarium Way from Seaside Way 28 Ito Shoreline Drive, Cedar Avenue from Shoreline Drive to Seaside Way, Paseo from Pine
