SECOND AMENDMENT TO AGREEMENT NO. 34895

THIS SECOND AMENDMENT TO PARKING OPERATIONS AND MANAGEMENT AGREEMENT NO. 34895 is made and entered, in duplicate, as of January 13, 2020, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on January 7, 2020, by and between LAZ PARKING CALIFORNIA, LLC, a Connecticut limited liability company ("Operator"), with a place of business at 10635 Santa Monica Blvd., Suite 145, Los Angeles, California 90025, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with Citywide Parking Operations and Management Services; and

WHEREAS, City and Operator (the "Parties") entered into Agreement No. 34895 (the "Agreement") whereby Operator agreed to perform these services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to add additional parking locations and increase the Agreement by \$4,522,813 for a total not to exceed amount of \$13,971,791; and

WHEREAS, the Parties desire to add additional parking locations and upgrades and increase the Agreement by \$1,171,884;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 1.A. of Agreement No. 34895 is hereby amended to read as follows:
 - "A. Operator shall provide all parking management services necessary to operate, maintain and manage the parking facilities" ("Parking Facilities") more particularly described in Exhibit "A-2" and referenced appendices, attached to this Agreement and incorporated herein by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed Fifteen Million One Hundred Forty-Three

Thousand Six Hundred Seventy-Five Dollars (\$15,143,675), at the rates or charges shown in Exhibit "B" (the "Cost Proposal")."

- 2. Appendix A-1 to Exhibit "A-2" is amended to include additional parking locations and upgrades attached hereto and incorporated herein as Exhibit "A-4".
- 3. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 34895 are ratified and confirmed and shall remain in full force and effect.
