

SECOND AMENDMENT TO AGREEMENT NO. 34657

THIS SECOND AMENDMENT TO AGREEMENT NO. 34657 is made and entered, in duplicate, as of March 19, 2020, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on June 13, 2017, by and between ENVIRON ARCHITECTURE, INC., a California corporation ("Consultant"), with a place of business at 100 Oceangate P200, Long Beach, CA 90802, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 34657 (the "Agreement") whereby Consultant agreed to provide as needed urban planning design services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to extend the term to June 30, 2020; and

WHEREAS, the Parties desire to extend the term one (1) additional one-year period and add \$100,000 to the Agreement for a total not to exceed amount of \$700,000;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 1.A. of the Agreement is hereby amended to read as follows:

"A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed Seven Hundred Thousand Dollars (\$700,000), at the rates or charges shown in Exhibit "B"."

2. Section 2 of the Agreement is hereby amended to read as follows:

"2. TERM. The term of this Agreement shall commence at midnight on July 1, 2017, and shall terminate at 11:59 p.m. on June 30, 2021, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner. The Parties have the option to extend the term one (1) additional one-year period at the

discretion of the City Manager."

3. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 34657 are ratified and confirmed and shall remain in full force and effect.
