## SECOND AMENDMENT TO AGREEMENT NO. 34661

THIS SECOND AMENDMENT TO AGREEMENT NO. 34661 is made and entered, in duplicate, as of March 19, 2020, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on June 13, 2017, by and between RDC-S111, INC. DBA STUDIO 111, a California corporation ("Consultant"), with a place of business at 245 E. Third Street, Long Beach, California 90802, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 34661 (the "Agreement") whereby Consultant agreed to provide as needed urban planning design services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to extend the term to June 30, 2020 and add \$200,000; and

WHEREAS, the Parties desire to extend the term one (1) additional one-year period:

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 2 of the Agreement is hereby amended to read as follows:
- "2. TERM. The term of this Agreement shall commence at midnight on July 1, 2017, and shall terminate at 11:59 p.m. on June 30, 2021, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner. The Parties have the option to extend the term one (1) additional one-year period at the discretion of the City Manager."
- Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 34661 are ratified and confirmed and shall remain in full force and effect.
