## FOURTH AMENDMENT TO CONTRACT NO. 33664

THIS FOURTH AMENDMENT TO CONTRACT NO. 33664 is made and entered, in duplicate, as of July 17, 2020, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on July 14, 2020, by and between FERGUSON ENTERPRISES, LLC, a Virginia limited liability company, formerly known as FERGUSON ENTERPRISES, INC. a Virginia corporation ("Contractor"), whose address is 12500 Jefferson Avenue, Newport News, Virginia 23602, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Contractor (the "Parties") entered into Contract No. 33664 (the "Contract") whereby Contractor agreed to provide as-needed plumbing supplies; and

WHEREAS, the Parties entered into a First Amendment to the Contract to extend the term to January 25, 2018 and add \$910,000 for a total not to exceed amount of \$2,730,000; and

WHEREAS, the Parties entered into a Second Amendment to the Contract to extend the term to January 25, 2019 and attach an updated rate sheet; and

WHEREAS, the Parties entered into a Third Amendment to extend the term and add \$300,000 to the Contract to allow for the completion of a new procurement process; and

WHEREAS, the Parties desire to extend the term to December 31, 2020 and add \$641,500 for a total not to exceed amount of \$3,671,500;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. The extended term of this Contract shall commence at midnight on January 26, 2019, and shall terminate at 11:59 p.m. on December 31, 2020, unless sooner terminated as provided in this Contract, or unless the services or the Project is completed sooner.
