## FIFTH AMENDMENT TO AGREEMENT NO. 33499

THIS FIFTH AMENDMENT TO AGREEMENT NO. 33499 is made and entered, in duplicate, as of October 7, 2020, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting only October 6, 2020, by and between MLA GREEN, INC. DBA MIA LEHRER & ASSOCIATES, a California corporation, with a place of business at 251 S. Mission Road, Los Angeles, California 90033 ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 33499 (the "Agreement") whereby Consultant agreed to provide as-needed landscape architectural services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to extend the term to August 1, 2017 and add \$250,000 for a total not to exceed amount of \$500,000; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to extend the term to August 1, 2018 and add \$500,000 for a total not to exceed amount of \$1,000,000; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to extend the term to August 1, 2019, update the City Representative and attach a revised rate sheet; and

WHEREAS, the Parties entered into a Fourth Amendment to the Agreement to extend the term to August 1, 2020; and

WHEREAS, the Parties desire to extend the term one (1) additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 2 of the Agreement is hereby amended to read as follows:
