RECOMMENDATION:

Adopt Resolution declaring the results of the General Municipal Election held on Tuesday, November 3, 2020. (Citywide)

DISCUSSION

The City Attorney has prepared a resolution declaring the results of the General Municipal Election held on November 3, 2020, to adopt Measure US -- General Purpose Oil Barrel Production Tax (Barrel Tax), elect members to City Council Districts 2, 6 and 8, and elect a member to the Long Beach Unified School Governing Board Member District 2.

The Los Angeles County Registrar-Recorder/County Clerk's Certificate of the canvass of the Election Returns and Statement of Votes Cast, attached as Exhibit A to the Resolution, provides the number of votes by precinct.

This matter was reviewed by Deputy Attorney Amy Webber on November 30, 2020 and by Budget Management Officer Rhutu Amin Gharib on November 30, 2020.

TIMING CONSIDERATIONS

Approval of the recommended action on December 8, 2020 will meet the provisions of California Elections Code Sections 10262 and 10263, and Long Beach Charter Section 200, which establishes the start of each Council Member term as commencing on the third Tuesday of December following the date of the election.

FISCAL IMPACT

This recommendation has no fiscal impact and no staffing impact beyond the normal budgeted scope of duties and is consistent with existing City Council priorities. There is no local job impact associated with this recommendation.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH DECLARING THE RESULTS OF THE GENERAL MUNICIPAL ELECTION HELD IN THE CITY OF LONG BEACH, CALIFORNIA, ON TUESDAY, NOVEMBER 3, 2020, TO SUBMIT TO A VOTE OF THE QUALIFIED ELECTORS OF THE CITY ONE BALLOT MEASURE; THREE OFFICES ON THE CITY COUNCIL FROM DISTRICTS 2, 6 AND 8; ONE LONG BEACH UNIFIED SCHOOL DISTRICT GOVERNING BOARD MEMBER, DISTRICT NUMBER 2; AND DIRECTING THE CITY CLERK TO ISSUE A CERTIFICATE OF ELECTION TO THE CANDIDATES DECLARED TO HAVE BEEN ELECTED AT THE GENERAL MUNICIPAL ELECTION

WHEREAS, the City Council of the City of Long Beach did, by Resolutions Nos. RES-19-0159, RES-20-0040, RES-20-0085, duly call and provide for the holding of a General Municipal Election on Tuesday, November 3, 2020, to submit to a vote of the qualified electors of the City one (1) ballot measure; three (3) offices on the City Council from Districts 2, 6 and 8; and one (1) Long Beach Unified School District Governing Board Member, District Number 2; and

WHEREAS, the General Municipal Election was held in the City of Long Beach on Tuesday, November 3, 2020; and

WHEREAS, the Los Angeles County Registrar duly canvassed the returns of the election and has transmitted the results to the City Clerk;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

1	Section 1. A true and correct copy of the canvass of the votes cast in

Section 5. It is determined and declared that at the General Municipal Election, One Hundred Seven Thousand Forty (107,040) votes were cast in favor of Measure US and Eighty Thousand Four Hundred Seventy-Three (80,473) votes were cast against it, and that it received a majority of the votes cast and that such measure is hereby approved.

Section 6. That Cindy Allen received a majority of the votes cast for all candidates for the office of Member of the City Council from the Second District, and in accordance with the provisions of law governing the nomination and/or election of candidates for this office, Cindy Allen is declared elected to the office of Member of the City Council from the Second District for the full term of four (4) years commencing with the third Tuesday of December, 2020. The City Clerk is directed to issue Cindy Allen a Certificate of Election certifying to the election to this office for such term.

Section 7. That Suely Saro received a majority of the votes cast for all candidates for the office of Member of the City Council from the Sixth District, and in accordance with the provisions of law governing the nomination and/or election of candidates for this office, Suely Saro is declared elected to the office of Member of the City Council from the Sixth District for the full term of four (4) years commencing with the third Tuesday of December, 2020. The City Clerk is directed to issue Suely Saro a Certificate of Election certifying to the election to this office for such term.

Section 8. That Al Austin II received a majority of the votes cast for all candidates for the office of Member of the City Council from the Eighth District, and in accordance with the provisions of law governing the nomination and/or election of candidates for this office, Al Austin II is declared elected to the office of Member of the City Council from the Eighth District for the full term of four (4) years commencing with the third Tuesday of December, 2020. The City Clerk is directed to issue Al Austin II a Certificate of Election certifying to the election to this office for such term.

Section 9. That Erik Miller received a majority of the votes cast for all




