SECOND AMENDMENT TO CONTRACT NO. 34754

THIS SECOND AMENDMENT TO CONTRACT NO. 34754 is entered into, in duplicate, effective as of October 25, 2019, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on July 18, 2017, by and between CALIFORNIA STATE UNIVERSITY, LONG BEACH - COLLEGE OF CONTINUING AND PROFESSIONAL EDUCATION, with offices located at 630 State University Drive, #332, Long Beach, California 90840 ("Contractor") and the CITY OF LONG BEACH, a municipal corporation ("City") and administering entity for Pacific Gateway Workforce Investment Network.

WHEREAS, City and Contractor (the "Parties") entered into Contract No. 34754 (the "Contract") whereby Contractor agreed to provide vocational skills training and educational support in various sectors to Pacific Gateway participants; and

WHEREAS, the Parties entered into a First Amendment to the Contrac to extend the term to December 30, 2019; and

WHEREAS, the Parties desire to extend the term one (1) additional one-year period and add \$150,000;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 2.A. of the Contract is hereby amended to read as follows:

"A. The term of this Contract ("Term") shall be deemed to have commenced as of January 1, 2017, and unless sooner terminated pursuant to the provisions hereof, shall terminate on December 30, 2020. Either of the parties hereto shall have the right to terminate this Contract in its entirety at any time during the Term for any or no reason whatsoever by giving fifteen (15) days prior written notice of termination to the other party. City shall have the additional right to cancel any part of this Contract at any time during the Term for any reason whatsoever by giving fifteen (15) days' notice of such cancellation to the Contractor."
