FIFTH AMENDMENT TO AGREEMENT NO. 34122

THIS FIFTH AMENDMENT TO AGREEMENT NO. 34122 is made and entered, in duplicate, as of November 30, 2020, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on November 17, 2020, by and between COMPREHENSIVE HOUSING SERVICES, INC., a California corporation ("Consultant"), with a place of business at 8840 Warner Avenue, #203, Fountain Valley, California 92708, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 34122 (the "Agreement") whereby Consultant agreed to provide as-needed professional compliance monitoring services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to add \$130,000 for a total not to exceed amount of \$370,000 and extend the term to November 14, 2019; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to add \$201,000 for a total not to exceed amount of \$571,000; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to add \$100,000 for a total not to exceed amount of \$671,000 and extend the term to November 14, 2020; and

WHEREAS, the Parties entered into a Fourth Amendment to the Agreement to add \$40,000 for a total not to exceed amount of \$711,000; and

WHEREAS, the Parties desire to extend the term one (1) additional two-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 2 of the Agreement is hereby amended to read as follows:
- "2. <u>TERM</u>. The term of this Agreement shall commence at midnight on
