THIS SECOND AMENDMENT TO PROJECT LABOR AGREEMENT NO. 33859 is made and entered, in duplicate, as of February 3, 2021, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on February 2, 2021, by and between the City of Long Beach, a municipal corporation ("City"), the Los Angeles/Orange Counties Building and Construction Trades Council ("Trades Council"), and the signatory Craft Councils and Local Unions entering into this Agreement (collectively, the "Union" or "Unions").

SECOND AMENDMENT TO PROJECT LABOR AGREEMENT NO. 33859

WHEREAS, City, the Trades Council and the Unions (the "Parties") entered into Project Labor Agreement No. 33859 (the "PLA Agreement") to establish the labor relations policies and procedures for the City, the Contractors awarded contracts for Project Work and for the crafts persons employed by the Contractors and represented by the Unions engaged in the Project Work as more fully described therein; and

WHEREAS, the PLA Agreement expired on or about May 22, 2020; and WHEREAS, the Parties have been operating under the terms and conditions of the PLA Agreement despite it expiring on or about May 22, 2020; and

WHEREAS, the Parties are in the process of negotiating a new Project Labor Agreement; and

WHEREAS, the Parties entered into a First Amendment to the PLA Agreement to extend the term of the PLA Agreement retroactively from the time of its termination to December 31, 2020; and

WHEREAS, the Parties desire to again extend the term while negotiations for a new Project Labor Agreement are on-going;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. The Agreement of the PLA Agreement shall be extended retroactively from its termination on or about May 22, 2020 to March 1, 2021, or the effective date of the

new Project Labor Agreement, whichever occurs first in time.

2. Except as expressly modified herein, all of the terms and conditions contained in PLA Agreement No. 33859 are ratified and confirmed and shall remain in full force and effect.

IN WITNESS WHEREOF, the Parties have caused this document to be duly executed with all formalities required by law as of the date first stated above.

FURTHER, by signing this document, the Trades Council certifies that it has the authority to bind all Signatory Unions to the PLA and that by executing the document below is consenting to and entering into this Amendment on behalf of all Signatory Unions.
