**Executive Summary:**


The Comprehensive Annual Financial Report (Report) comprises the audited financial statements of the Water and Sewer Funds, which collectively represent the Water Department's financial position and results of operations for the fiscal year 2020.

The Report is presented in three sections: Introductory, Financial and Statistical. The Introductory Section includes a letter of transmittal with pertinent Department background information. The Financial Section includes the Independent Auditors' Report issued by KPMG LLP, the City's external independent certified public accounting firm; a Management Discussion and Analysis, which provides a narrative introduction, overview and analysis of the financial statements; and the financial statements with related footnotes. The Statistical Section includes relevant Department financial and operational data, covering ten-year historical trends where applicable. KPMG LLP has issued an unqualified ("clean") opinion on the Department's financial statements for the fiscal year ended September 30, 2020.

In addition, KPMG LLP has issued a separate "Independent Auditors' Report on Internal Control over Financial Reporting and on Compliance and Other Matters Based on an Audit of Financial Statements Performed in Accordance with Government Auditing Standards". The results of their audit tests did not identify any deficiencies in internal control considered to be material weaknesses and disclosed no instances of noncompliance or other matters that are required to be reported under Government Auditing Standards. This report is also included as a separate attachment.

Summaries of preliminary, unaudited Department financial information and results of operations for the fiscal year were presented to the Board on a quarterly basis throughout the fiscal year. There were no material adjustments to those figures as a result of the financial audit.


