I propose the following:  1. a unified tree trimming policy applicable to the entire city.  2. The policy must combine the two existing policies and adopt the most stringent aspects of each policy, including the following:  3. Tree replacement must be a minimum of 2:1 ratio, except for the tree-poor North, West, and South Park Sectors where the minimum replacement ought to be 3:1  4. Replacement trees must be a minimum of 24 inch box.  5. The qualified reviewer used to determine tree removal must be an independent certified arborist.  6.
