## **Board of Water Commissioners**

### **Subject:**

Adopt Specifications WD-18-21 for the On-Call Services for Emergency Water and Sewer Repair and authorize the General Manager to enter into three (3) separate two-year contracts with (1) Ramona, Inc., (2) Mike Prlich & Sons, Inc., and (3) Charles King Company, Inc., each in the amount of \$750,000, with provision to extend for two (2) separate consecutive periods of one year each, subject to approval of the Board.

### **Executive Summary:**

Currently, LBWD has contracts with three contractors, Charles King Company, Inc., Ramona, Inc., and W.A. Rasic Construction Company, Inc., to perform Emergency Water and Sewer Repairs. The contract with Charles King Company, Inc. will expire on July 31, 2021, and the other two contracts will expire on August 15, 2021.

In order to maintain a bench of emergency contractors, on April 29, 2021 and May 6, 2021, staff published the Notice of Inviting bids for On-Call Services for Emergency Water and Sewer Repair as required by Public Contract Code Section 22037. The purpose of these construction contracts is to establish a new rotating list of on-call contractors with relevant experience who are required to respond within short notice to emergency water and sewer repair work.

On May 28, 2021, six (6) bids were received and opened. Bid evaluation was performed considering the quantities and rates from a sample project. A bid summary is attached for reference. The bids submitted by Ramona, Inc., Mike Prlich & Sons, Inc., and Charles King Company, Inc. were found to be in conformance with the bid documents.


### **Recommendation/Fiscal Impacts**

Adopt Specifications WD-18-21 for the On-Call Services for Emergency Water and Sewer Repair and authorize the General Manager to enter into three (3) separate two-year contracts with (1) Ramona, Inc., (2) Mike Prlich & Sons, Inc., and (3) Charles King Company Inc., each in the amount of \$750,000, with provision to extend for two (2) separate consecutive periods of one year each, subject to approval of the Board.

**Fiscal Impact:** The funds are available in the Water and Sewer Budget.
