SIXTH AMENDMENT TO CONTRACT NO. 33664

THIS SIXTH AMENDMENT TO CONTRACT NO. 33664 is made and entered, in duplicate, as of May 19, 2021, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on May 4, 2021, by and between FERGUSON US HOLDINGS, INC., a Virginia corporation, formerly known as FERGUSON ENTERPRISES, INC. a Virginia corporation ("Contractor"), whose address is 12500 Jefferson Avenue, Newport News, Virginia 23602, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Contractor (the "Parties") entered into Contract No. 33664 (the "Contract") whereby Contractor agreed to provide as-needed plumbing supplies; and

WHEREAS, the Parties entered into a First Amendment to the Contract to extend the term to January 25, 2018 and add \$910,000 for a total not to exceed amount of \$2,730,000; and

WHEREAS, the Parties entered into a Second Amendment to the Contract to extend the term to January 25, 2019 and attach an updated rate sheet; and

WHEREAS, the Parties entered into a Third Amendment to the Contract to extend the term and add \$300,000 to the Contract to allow for the completion of a new procurement process; and

WHEREAS, the Parties entered into a Fourth Amendment to the Contract to extend the term to December 31, 2020 and add \$641,500 for a total not to exceed amount of \$3,671,500; and

WHEREAS, the Parties entered into a Fifth Amendment to the Contract to extend the term to June 30, 2021 and add \$256,000 for a total not to exceed amount of \$3,927,500; and

WHEREAS, the Parties desire to extend the term to October 31,2021 and add \$150,000 for a total not to exceed amount of \$4,077,500;

- 2. One Hundred Fifty Thousand Dollars (\$150,000) is hereby added to the Contract extension terminating on October 31, 2021 for a total contract not to exceed amount of Four Million Seventy-Seven Thousand Five Hundred Dollars (\$4,077,500).
- 3. Except as expressly amended herein, all terms and conditions in Contract No. 33664 are ratified and confirmed and shall remain in full force and effect.
