Either of the parties hereto shall have the right 20 to terminate this Contract in its entirety at any time during the Term for any or no reason 21 whatsoever by giving fifteen (15) days prior written notice of termination to the other party. 22 City shall have the additional right to cancel any part of this Contract at any time during the 23 Term for any reason whatsoever by giving fifteen (15) days' notice of such cancellation to 24 the Contractor." 25

26 contained in Contract No. 34711 are ratified and confirmed and shall remain in full force
27 and effect.
