SEVENTH AMENDMENT TO AGREEMENT NO. 33912 33912

THIS SEVENTH AMENDMENT TO AGREEMENT NO. 33912 is made and entered, in duplicate, as of June 9, 2021 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on June 8, 2021, by and between KARDENT, a California corporation ("Consultant"), with a place of business at 11 Golden Shore, Suite #540, Long Beach, California 90802, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 33912 (the "Agreement") whereby Consultant agreed to provide as-needed architectural services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to add \$500,000 for a total not to exceed amount of \$900,000 and extend the term to July 19, 2018; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to add \$300,000 for a total not to exceed amount of \$1,200,000 and extend the term to July 19, 2019; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to update the rates/charges to include two (2) new sub-consultants; and

WHEREAS, the Parties entered into a Fourth Amendment to the Agreement to extend the term to July 19, 2020; and

WHEREAS, the Parties entered into a Fifth Amendment to the Agreement to add \$800,000 for a total not to exceed amount of \$2,000,000; and

WHEREAS, the Parties entered into a Sixth Amendment to the Agreement to extend the term to July 19, 2021; and

WHEREAS, the Parties desire to add \$600,000 to the Agreement for a total not to exceed amount of \$2,600,000 and extend the term one (1) additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 1.A. of the Agreement is hereby amended to read as follows:
- "A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed Two Million Six Hundred Thousand Dollars (\$2,600,000), at the rates or charges shown in Exhibit "B"."
 - 2. Section 2 of the Agreement is hereby amended to read as follows:
- "2. <u>TERM</u>. The term of this Agreement shall commence at midnight on July 20, 2015, and shall terminate at 11:59 p.m. on July 19, 2022, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner."
- Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 33912 are ratified and confirmed and shall remain in full force and effect.
