AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AMENDING THE USE DISTRICT MAP OF THE CITY OF LONG BEACH AS SAID MAP HAS BEEN ESTABLISHED AND AMENDED BY AMENDING PORTIONS OF PART 5 OF SAID MAP FROM BELMONT PIER PLANNED DEVELOPMENT DISTRICT (PD-2) SUBAREA 4 TO R-4-R (MODERATE-DENSITY MULTIPLE RESIDENTIAL), AND FROM PD-2 SUBAREA 5 TO PD-2 SUBAREA 4

The City Council of the City of Long Beach ordains as follows:

15 Section 1. Environmental documentation having been prepared, 16 certified, received and considered as required by law, and the City Council hereby 17 finding that the proposed change will not adversely affect the character, livability or 18 appropriate development of the surrounding area and that the proposed change is 19 consistent with the goals, objectives and provisions of the General Plan, the official Use 20 District Map of the City of Long Beach, as established and amended, is further amended 21 by amending portions of Part 5 of said Map from Belmont Pier Planned Development 22 District (PD-2) Subarea 4 to R-4-R (Moderate-density Multiple Residential), and from PD-23 2 Subarea 5 to PD-2 Subarea 4.

Section 2. That portion of Part 5 of said Map that is amended by this
 ordinance is depicted on Exhibit "A" which is attached hereto and by this reference made
 a part of this ordinance and the official Use District Map of the City.

Section 3. All ordinances and parts of ordinances in conflict herewith are
hereby repealed.


