5 1. Section 1.A. of the Agreement is hereby amended to read as follows:
6 "A. Consultant shall furnish specialized services more particularly
7 described in Exhibit "A", attached to this Agreement and incorporated by this
8 reference, in accordance with the standards of the profession, and City shall pay for
9 these services in the manner described below, not to exceed Two Million Six
10 Hundred Thousand Dollars (\$2,600,000), at the rates or charges shown in Exhibit
11 "B".

12 2. Section 2 of the Agreement is hereby amended to read as follows:
13 "2. TERM. The term of this Agreement shall commence at midnight on
14 August 1, 2014, and shall terminate at 11:59 p.m. on August 1, 2022, unless sooner
15 terminated as provided in this Agreement, or unless the services or the Project is
16 completed sooner."

17 3. The Rates in Exhibit "B" to the Agreement and "B-1 "to the Fourth
18 Amendment are hereby amended in accordance with Exhibit "B-2", attached hereto and
19 incorporated by this reference.

20 4. Except as expressly modified herein, all of the terms and conditions
21 contained in Agreement No. 33504 are ratified and confirmed and shall remain in full force
22 and effect.






