Consultant shall furnish specialized services more particularly 22 described in Exhibit "A", attached to this Agreement and incorporated by this 23 reference, in accordance with the standards of the profession, and City shall pay for 24 these services in the manner described below, in an annual amount not to exceed 25 Four Hundred Thousand Dollars (\$400,000), at the rates or charges shown in 26 Exhibit "B"."

27 2. Except as expressly modified herein, all of the terms and conditions 28 contained in Agreement No. 35785 are ratified and confirmed and shall remain in full force
