
### How is an outdoor fire defined?

- < 500' 91, 405, 605, 710 Freeways
- < 500' LA, San Gabriel, and Coyote Creek



# Recent fire in Council District 7

- South of 405 Fwy / East of 710 Fwy
- 3 Acres burned
- 26 Units committed (equivalent to a third alarm fire)
- Auto Aid response from LA County (Two engines + Battalion Chief)
- Resource drawdown for a significant amount of time





# Recent fire in CD7


- All southbound lanes shut down except for HOV
- Offramps shutdown
- Major water supply issues
- Units on scene for 5 hours (initial attack to mop-up)
- Multiple 911 calls throughout the next day (larger fuels may smolder for multiple days)











### Consistent increase in trash, brush, & grass fires...






# What's changed?

Dry/dead vegetation and ground cover

Overgrown areas with significant litter, duff, and ladder fuels. (Also provides concealment for encampments)

Increase PEH encampments in and adjacent to heavily vegetated areas

- Cooking fires
- Heating fires
- Burning trash
- Arson







Encampments come and go from embankments lining all freeways. Main areas of focus with large encampments include:

- 405 & 710 interchanges
- 710 & 91 interchanges
- 405 South, South of Atlantic
- 405 S. transition to 605 N.
- 91 Fwy at Cherry and Paramount
- 103 Fwy at Willow
- Caspian Drainage
- 405 Fwy at Bellflower Blvd.
- 405 Fwy at Lakewood Blvd.
- 405 Fwy North of Stearns St.








### Areas of concern along riverbeds...

Homeless encampments are continually disassembled and cleaned up but quickly reappear along the many riverbeds in Long Beach. Large camps are located at:

- San Gabriel North of 2<sup>nd</sup> Street
- San Gabriel at the 405 Fwy
- Coyote Creek at Willow
- Nearly every overpass of the LA River
- Coyote Creek at Wardlow Rd.







# Misc. areas of concern throughout the City...

Other miscellaneous encampments throughout the City include:

- Shoreline Dr. at the Convention Center
- Shoreline Dr. around Catalina Landing
- Anaheim St. and Walnut Ave.
- Nature Center (various locations)
- Wardlow at Los Coyotes Diagonal
- Traffic Circle (various locations)
- PCH and Clark
- 7<sup>th</sup> St. and Channel Dr.








### July 2021 – The Arson Unit investigated 47 fires. Of those, roughly 60% were deemed PEH related







### Fires under investigation



- Outdoor fires occur nearly every day
- Fires with no suspects, witnesses, or property damage are typically not reported or investigated
- The following are the total number of fires that were investigated by Council District in July

### Fires in vacant structures occupied by PEH



Fires related to PEH are not exclusive to outdoor areas. These include vacant structures throughout the City and under freeway overpasses. These become major safety hazards for first responders:

- Weakened structural members
- Exposure to bio-hazardous waste
- Illegal electrical
- Propane / butane bottles
- Breaches in walls and floors
- Drug paraphernalia
- Potential physical threats
- Confined space & access issues (bridges)





### Damage to property...

- On April 15, 2021, a small brush fire in Long Beach burned several vacant school buses.
- At least three school buses were destroyed.
- Brush fires travel with wind direction or topography. Residential neighborhoods, business parks, or city structures/equipment may be in this destructive path.







## Challenges created by outdoor fires

- Resource commitment for extensive periods of time, creating delays to service in "firstin" areas
- Increase in suppression foam consumption
- Excessive fatigue to fire personnel
- High risk operation working from freeways
- Exposure to bio-hazardous waste
- Extensive resources required
- Water supply issues
- Bridge encampment fires will create unique hazards and will involve multiple city departments to mitigate
