THIRD AMENDMENT TO CONTRACT NO. 35022

THIS THIRD AMENDMENT TO CONTRACT NO. 35022 is made and entered, in duplicate, as of August 12, 2021 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on August 3, 2021, by and between PARKWOOD LANDSCAPE MAINTENANCE, INC., a California corporation ("Contractor"), whose address is 16443 Hart Street, Van Nuys, California 91406, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Contractor (the "Parties") entered into Contract No. 35022 (the "Contract") whereby Contractor agreed to provide grounds maintenance services in the City of Long Beach; and

WHEREAS, the Parties entered into a First Amendment to the Contract to increase the annual contract amount to \$1,045,973.75 and attach an additional scope of work; and

WHEREAS, the Parties entered into a Second Amendment to the Contract to increase the annual contract amount to \$1,120,873.99 and attach an additional scope of work; and

WHEREAS, the Parties again desire to increase the annual contract amount to \$1,294,770 and attach an additional scope of work;

NOW, THEREFORE, in consideration of the mutual terms and conditions herein contained, the Parties agree as follows:

- 1. Section 2 of the Contract is hereby amended to read as follows:
- "2. PRICE AND PAYMENT. City shall pay to Contractor the amount(s) for work and services identified in Contractor's Bid for Ground Maintenance Services in the City of Long Beach, California, attached to the Contract as Exhibit "A", for the period of September 1, 2018 to August 31, 2019 an annual amount of One Million Thirty-Eight Thousand Five Hundred Ninety-Four Dollars (\$1,038,594); for the term of September 1, 2019 to August 31, 2020 an annual amount of One Million Forty-Five Thousand Nine

Hundred Seventy-Three Dollars and Seventy-Five Cents (\$1,045,973.75); for the term of September 1, 2020 to August 31, 2021, an annual amount of One Million One Hundred Twenty Thousand Eight Hundred Seventy-Three Dollars and Ninety-Nine Cents (\$1,120,873.99); and for the term of September 1, 2021 to August 31, 2021 an annual amount of One Million Two Hundred Ninety-Four Thousand Seven Hundred Seventy Dollars (\$1,294,770)."
