## FIRST AMENDMENT TO AGREEMENT NO. 35972

THIS FIRST AMENDMENT TO AGREEMENT NO. 35972 is made and entered, in duplicate, as of September 1, 2021 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on July 13, 2021, by and between CHOURA VENUE SERVICES dba GRAND FOOD BEVERAGE, THE GRAND, GRAND F&B, a California corporation ("Consultant"), with a place of business at 4101 E Willow St., Long Beach, California 90815, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with providing meal preparation and delivery services to the City's non-congregate shelter sites that have been activated in response to COVID-19 ("Project"); and

WHEREAS, the scope and magnitude of the response necessary to proactively slow the spread of, and combat, COVID-19 in the City is beyond the control of the services, personnel, equipment, and facilities of the City; and

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 35972 (the "Agreement") whereby Consultant agreed to provide these services; and

WHEREAS, the Parties desire to extend the term of the Agreement due to additional funding provided by the Federal Emergency Management Agency; and

WHEREAS, pursuant to Chapter 2.85 of the Long Beach Municipal Code, the City Manager and Purchasing Agent have the authority to approve purchases, rentals, or leases of goods or services related to a proclaimed emergency; and

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 2. of the Agreement is hereby amended to read as follows.
- "2. TERM. The Term of this Agreement shall commence at midnight on October 1, 2020, and shall terminate at 11:59 p.m. on April 30, 2022, with the option to
