These ordinance changes, for example, should not have been delayed until just 2 months before the compliance deadline. The excuses suggested in the staff memo frankly lack credibility. That said, I agree with the following statement: "It is imperative the City works to implement as much of the legislation as possible, including the adoption of an Ordinance for enforcement by the implementation date to avoid financial penalties."
