Correspondence has been received from Sheryl Bender, Personnel Officer for the Department of Parks, Recreation and Marine, requesting Civil Service Commission approval to reappoint resigned employee Carol Gonzalez to the classification of Accounting Clerk III. Staff has reviewed this request and recommends approval in accordance with Article V, Section 45 of the Civil Service Rules and Regulations.

Facts for Consideration:

- Ms. Gonzalez was hired as a Recreation Leader Specialist I/II-NC on October 21, 2006 in the Department of Parks, Recreation and Marine. She held various roles as a Non-Career Recreation Leader Specialist and Clerk Typist from October 2006 through November 2017. Ms. Gonzalez was selected as an Accounting Clerk in the Department of Parks, Recreation and Marine on November 25, 2017. She attained permanent status in the classification of Accounting Clerk on June 25, 2018.
- She resigned from her classified position in good standing on August 20, 2020.
- On October 19, 2021, Ms. Gonzalez reached out to Bureau Manager Elvira Hallinan, via email correspondence, requesting to be considered for reinstatement as an Accounting Clerk III with the Department of Parks, Recreation and Marine.
- Parks, Recreation and Marine intends to use requisition PR 22-011 for Ms. Gonzalez' reappointment. Approved requisition PR 22-011 is on file with the Civil Service Department and was received on October 28, 2021.
- Civil Service staff contacted Ms. Gonzalez on November 4, 2021. She is aware that she will need to serve a new probationary period and that all prior Civil Service rights have been severed.
