STAFF UPDATES

Commission Coordinator, Gina Overholt, reported on her recent meeting with Pacific Gateway staff. (Pacific Gateway is the workforce development agency for Long Beach, jointly operated by the city and the state's Employment Development Department). Pacific Gateway is interested in partnering with the Commission on the next Veterans Empowerment Training Session. She also attended a Southern California Grantmakers (SCG) meeting wherein she spoke with the lead organizers of a new Los Angeles County Veterans Pier Network. VPN is funded by the county and SCG. Overholt attended the city's first Veteran employees' meeting and reported on its upcoming events and activities.
