SUBCOMMITTEE UPDATES

Community Capacity Building Subcommittee Update

- Vice Chair Hui provided an update
 - The CCB Subcommittee and staff met on December 20 to discuss the Mayor's Fund to End Homelessness
 - A workflow draft was created to better understand the process for organizations applying to the Mayor's Fund
 - Subcommittee also discussed advanced payment
 - Amendments will be made to the application for Mayor's Fund and will be brought forth to HSAC once it has been finalized
 - Next CCB meeting is being scheduled for January 14th or January 28th

Fundraising Subcommittee Update

- Committee Member Solano provided an update
 - The Fundraising Subcommittee envelope has been delayed due to supply chain issues, estimated time for envelopes to go out is Tuesday January 11, 2022
 - Committee members to share Long Beach Mayor's Fund letter with each district councilmember

Policy Subcommittee Update

- Committee Member Pearson provided an update
 - Because of redistricting, getting acclimated in a new Council District is very important
 - Committee Member Pearson recommended that HSAC members be up to date with local candidates who are running for office in your new district

Continuum of Care Update

- Paul Duncan, Homeless Services Bureau Manager, provided an update
 - Continuum of Care (CoC) Board met in December
 - Allison Kripp announced that she is stepping down from the CoC Board due to her new role with the City of Long Beach
 - CoC Board Co-Chair Steve Be Cotte is no longer with DLBA, but will finish his current term
 - CoC Board will be selecting two new Co-Chairs in the near future.
