Jen Flores, Board Secretary, presented the Employees of the Month for May 2022.

"Hello, thank you. Very briefly I know that there's a survey going around right now about proposed changes to both the Long Beach Transit lines and bus stops along certain routes. A few months ago I provided public comment back in January in supportive Transit Equity Day, generally we know that public transportation is one of the most effective ways dollar for dollar to reduce carbon emissions in the transportation sector and especially now that the State has a budget surplus, I strongly encourage the Long Beach Transit Board of Directors to search for more grant funding and creative ways to keep our existing line and bus stops where they are as well as expand some of the amenities to them like shading and regular cleaning. Thank you."

CEO McDonald provided information about the California Transit Association (CTA) 2022 Spring Legislative Conference held on May 18, 2022 in Sacramento, CA.

CEO McDonald, Lisa Patton and Erlin Martinez attended the conference, in which Mr. McDonald, being a CTA Executive Board member was invited to participate on a panel to discuss the New Focus on the Transition to Zero-Emission Vehicles, which was moderated by Doran Barnes, CEO of Foothill Transit.

Director Price asked for clarification regarding if the contract was a one time fee or going to be an ongoing charge.

CEO McDonald responded that the contract is a one time fee, however, once the system is selected there may be licensing fee that will need to be presented and approved by the Board.

Vice Chair Sutton requested staff examine the helpfulness of the consultant throughout the year and consider adding an FTE.

City Representative Erikson commented that this type of agreement is very commonly used when procuring a technical system.
