Paul Duncan provided an overview of the scores awarded to the Long Beach Continuum of Care Application that the CoC submitted during the FY 2021 CoC Program Competition. The scores were divided into three sections: High Priority CoC Application Questions, CoC Scoring Summary, and Overall Scores for all CoCs. The scoring categories are as follows: CoC Coordination and Engagement; Addressing COVID-19; Project Capacity, Review and Ranking; Homeless Management Information System; Point-in-Time Count; System Performance; and Coordination with Housing and Healthcare Bonus Points. The total LB CoC application score was 138.75 points. Provided an overview of the 2016 - 2019 CoC Scores. Discussion ensued among the Board Members.

Paul Duncan presented on Homeless Housing, Assistance and Prevention Round 3 goals and strategies. Overview of Long Beach Homeless Action Plan, services provided, funding analysis, outcome goals, and strategies for goals.

The State of California, as part of its Homeless Housing Assistance and Prevention (HHAP) Round 3 application process, requires that each community create a homeless action plan. The application is due by June 30, 2022, and the funding must be spent down by June 30, 2026. The Long Beach Department of Health and Human Services, Homeless Services Bureau staff has hosted multiple community input sessions to hear from community members and ensure that the feedback of the community is reflected within the creation of the spending plan and outcome goals and strategies. Two Community Feedback Sessions were held on May 11 and May 17, 2022, and one Lived Experience /Expertise Session was held on May 19, 2022, for a total of three sessions.

The homeless action plan includes data elements such as the number of people currently experiencing homelessness, number of people currently served, and the identification of all funds used and budgeted to be used. Additionally, the State also requires agencies to establish Outcome Goals for the progress that they will make in preventing and reducing homelessness over the three-year period of July 1, 2021, through June 30, 2024. Outcomes Goals are not intended to be related to HHAP-3-funded activities alone, but rather are intended to represent jurisdictional or system-wide goals for making progress on preventing and ending homelessness through the implementation of the full range of federal, state, and local funding sources and through many other kinds of strategies and activities. Discussion ensued among the Board Members.

The LEAB Team presented on Creating a Lived Experience Advisory Board for the City of Long Beach Homeless Services Bureau. Overview of the Lived Experience Advisory Board Final Report and Fact Sheet. Discussed how the Homeless Services Bureau can best create a Lived Experience Advisory Board to advance equitable representation in policymaking for the City of Long Beach. The following methods were implemented: literature review, document analysis, and interviews. Overview of LEAB's analyzed, Long Beach interviews, policy options, and criteria.
