Aleta Freesmeier has made a claim for injuries allegedly sustained in the course of her employment with the City of Long Beach. The Economic Development and Finance Committee on August 1, 2006, approved the submission to the Workers' Compensation Appeals Board of Stipulations with Request for Award by the City and Aleta Freesemier, based upon an 86 percent disability rating, with a further provision for a Life Pension at the rate of \$100.50 per week to be paid after the permanent disability has been paid in full. This would include a provision for lifetime medical care as may be necessary.
