Recommendation to continue the public hearing to vacate the portion of Elm Avenue, between Spring Street and the unnamed east-west public alley south of 31st Street, the unnamed east-west public alley between Elm Avenue and Pasadena Avenue, north of Spring Street and south of 31st Street, and the unnamed north-south public alley between Spring Street and 31st Street, east of Elm Avenue and west of Pasadena Avenue, to October 6, 2020. (District 7)

On July 14, 2020, the City Council adopted Resolution No. RES-20-0082 (Attachment A), setting August 18, 2020 as the date for a public hearing to vacate the portion of Elm Avenue, between Spring Street and the unnamed east-west public alley south of 31<sup>st</sup> Street, the unnamed east-west public alley between Elm Avenue and Pasadena Avenue, north of Spring Street and south of 31<sup>st</sup> Street, and the unnamed north-south public alley between Spring Street and 31<sup>st</sup> Street, east of Elm Avenue and west of Pasadena Avenue.

City Council action to continue the hearing to October 6, 2020, to allow for additional time for public noticing is requested.

This matter was reviewed by Deputy City Attorney Erin Weesner-McKinley on August 4, 2020. Due to time constraints, no Budget Office review was able to be conducted.

City Council action is requested on August 18, 2020, to allow for the public hearing to be continued to October 6, 2020.

There is no fiscal or local job impact associated with this recommendation. This recommendation has no staffing impact beyond the normal budgeted scope of duties and is consistent with existing City Council priorities.
