The 7th Annual Ms. Single Mom Empowerment Forum is SUEF's pre-Mother's Day celebration. The goal of the event is to celebrate and uplift single moms by offering single-parent female-headed families a full day of access to empowering business, educational, financial, family, health/wellness, and legal speakers along with other relevant resources.
